How has the Women's Caucus formed? *Women in Congress 1917-2006* is an updated version of House document 101-238, entitled *Women in Congress 1917-1990*. It answers these and many more questions. Designed for students and a general audience, this extensive volume features biographical profiles and photographs of past and current Members. The first part is arranged chronologically in to four generational time periods, with introductory essays describing institutional developments, legislative agendas, and societal trends that influenced each generation of women. The final part contains profiles of current Members.
